**Number and Amount of Scholarships; Distribution of Funds**

Twenty (20) parent and twenty-five (25) staff scholarships will be drawn in the amount of \$200.00 each. Winners will be announced at the 2012 KHSa Annual Conference with checks to be sent (following the Conference) to the respective Head Start Directors for distribution to the parent and staff scholarship winners.

**Eligibility for Scholarships**

• **Staff Scholarships**

Nominations will be accepted for Kentucky Head Start educational staff (teachers and teacher assistants) who are pursuing a qualifying degree (CDA Certification or an Associate's Degree or Bachelor's Degree in Early Childhood Education).

• **Parent Scholarships**

Nominations will be accepted from all Kentucky parents of currently-enrolled Head Start children provided the parent is currently enrolled in a college class or program.

• **\*\*\*NOTICE Change in procedure\*\*\* You no longer need to submit proof of enrollment in school with the nominations!!!**

**All parent and staff scholarship nominations must include a letter from the Head Start Director certifying that each of their nominees is enrolled in school. The letter is to list out all of the individual names that the agency is nominating. Please submit only one letter per agency.**

All scholarship applications must be submitted on the parent or staff form with proof of enrollment in an acceptable educational program to be considered.
